    - Section 1 Objectives: add -Follow USLBA Rules with variances as noted in the conditions of play for that tournament.
    - Section 2 Preparations delete sentence that starts: "Paid up membership is not required for leads and vices tournament..." add – Arrange for an umpire and ensure the umpire kit is stocked and ready for use"
    - Section 3 Draw Players must play in the position as drawn. Delete "check the names to make sure the players are equal in strength" Delete paragraph -"Try to avoid husband and wife on the same team..."
    - -Section 4 Procedures Delete Dead end language and add "If the jack leaves the rink of play during an end it will be respotted to the center line at the 2 meter mark and play will continue" Add – Ten end games will have a 1¾ hour time limit Add – notify the publicity chairperson, webmaster and past president of results

Section 5 Scoring – tournament committee will do it's best to minimize the number of times a team has to play on an outside rink.

Section 6 Entry Fee – amend to \$5 entry fee

Section 8 Tournament Details – Separate regular tournaments from Special Events. All tournaments will be 10 ends. Singles dress will be all whites, other tournaments team colours or whites.
